Item 1 - Approval of Agenda

Item 2 – Approval of Minutes

Tooley Water District September 20, 2018

Present: Richard Pontow, John Amery, Carol Mauser, Debby Jones, Dave Pratt

Carol opened the meeting at 7:19 pm (due to phone hook connection)

Carol asked for a motion to approve the agenda. John made motion to approve the agenda. Richard seconded. All approved.

Debby made a motion to approve the August, 2018 meeting minutes. John seconded. All approved.

John provided the financial report which included the following: Savings: \$38,578.20 Checking: \$8,342.79

John indicated that Hi-lands costs went up slightly due to maintenance invoices. The Liberty Mutual Insurance rate increased by \$13 due to a small increase in the amount of bond insurance (\$50,000). Currently our revenue is 10% higher than projected. We have spent slightly more on materials and services than forecasted for this point in the budget cycle. John shared the invoices that Hi-Land turned in for maintenance which equated to \$64.50.

Water loss was lower than July despite a higher increase in water pumped. This may be an indication that some of the fixes, such as the replacing water meters, has helped but more exploration is still needed into the overall water loss issue.

John provided an update on the Safe Drinking Water Revolving Water Fund. This grant can be a "forgivable" loan as long as the water district fulfills the contract within the two year time. Grant funds are available through a reimbursement process. John shared information on possible requirements of Request For Qualifications (RFQ). The grant will assist in asset mapping and leak detection.

Debby made the motion to authorize Chairperson Carol Mauser to sign on behalf of Tooley Water District's "Safe Drinking Water Revolving Loan Fund Financing Contract" as associated with project number "R19002" with the State of Oregon. John seconded. Motion approved. John will provide an additional document that requires all board member signatures.

Board members briefly discussed if the district needed to come up with an authorization policy for maintenance repairs as well as emergency situations. Issue will be discussed in more detail at a future board meeting.

Board discussed the issue of filing liens for unpaid/shutoff water services. There is potentially \$400 outstanding on an account where the owner has recently passed away. Debby made a motion to authorize John Amery to work through the process of filing a lien once water is shutoff at a property.

Richard seconded. Motion approved.

The District is required to file an <u>In Lieu of Audit</u> document. Debby made a motion to accept Resolution 2018-09-20 which authorizes John Amery as its registered agent in Oregon. Dave seconded. Motion passed.

John shared copies of receipts for reimbursements.

Board discussed meeting conflicts and will deal with them on a case by case basis.

Carol adjourned the meeting 8:25 pm
